

## **ROYALTY-FREE LICENSE AGREEMENT FOR ACIDFANATIC LOOPS LIBRARIES**

This Acidfanatic Loops License Agreement is a legally binding agreement between you (an individual or single entity) and Acidfanatic to use the Loops on an Acidfanatic Loops CD you have purchased a license for. By either licensing, copying and/or otherwise using any portion of this Loops CD, you are agreeing to be bound by the terms of this license agreement. If you do not agree with the terms of this license agreement then please do not use the Loops on the CD.

**GRANT OF LICENSE** . Acidfanatic, as Licensor, grants to you, the Licensee, a limited, nonexclusive right to use one (1) copy of each Loops CD, purchased by you, at a time on a single computer for your own individual use in composing musical works. You are free to use the Loops on the CD in your own original compositions without any restriction. The Loops on the CD and any portion thereof may not be resold or redistributed as loops, music beds and/or clips except as otherwise combined into your own original musical works. All other rights that are not expressly granted to you the Licensee are reserved by Acidfanatic. It is important to understand that these Loops CD's are licensed and not sold to you and that copyright laws, international copyright treaties as well as other intellectual property laws & treaties protect these Loops CD's.

**LOOPS CD OWNERSHIP** . As the official Licensee, you are the owner of the physical CD on which the Loops CD is recorded on only. Acidfanatic retains the full and complete title to the Loops CD and any or all copies of the Loops CD, regardless of whatever the type of media or the form in which original copies might exist. The License you have purchased is not in any way a sale of the original Loops CD or any of the material embodied within it.

**COPYRIGHT** . All interest, rights and title to the Loops CD and any copies of this Loops CD are owned by Acidfanatic. International treaty provisions and copyright laws protect these Loops CD's. Accordingly, you must treat these Loops CD's just like any other copyrighted material, except that you may make (2) copies for backup purposes only.

**RESTRICTIONS ON USE** . You may not use these Loops CD's on more than one computer at a time without buying additional licenses. You may not sublicense, lend, distribute, share, rent, lease or otherwise make any of the Loops on these Loops CD's available to any third party in any manner (this includes Internet Websites, FTP and Filesharing sites as well as Local Area Networks). You may not adapt, modify or create derivative works from any part of the Loops CD other than as combined by you into your own original musical work(s) in accordance with this License. You may not alter or remove any trademark, copyright or other proprietary notice that is contained in the Loops CD or use the Loops CD in any other manner that is not set forth in this License.

**ASSIGNMENT** . You have the right to assign the Loops CD to another third party only if they are willing to agree to be bound by all the terms and conditions of this License. If you do assign the Loops CD to another party, all your rights under this License will immediately terminate and you must stop using the Loops CD, delete any and all copies of the Loops CD from your computer(s) on which it has been installed and provide the original Loops CD to the new Licensee you are assigning the rights of this License to. You may not under any circumstances keep the original Loops CD or any copies you may have made.

**TERMINATION** . If you fail to comply with any provision of this License your right to use the Loops CD will terminate automatically. If the License is terminated you must immediately stop using the Loops CD, destroy the Loops CD and all copies of it and delete any and all copies of the Loops CD from your computer(s) on which it may have been installed.
